## GOLDEN BOOK OF WORLD RECORDS

## **General Rules and Guidelines**

- Golden Book of World Records does not promote or accept attempts or records that can lead to any kind of destruction or harm to property, health, morality or general well-being of an individual/organization/society. Similarly, the record/record attempt should not hurt or cause any kind of injury to any animal/s.
- Approval or disapproval of any attempt of record will be solely the decision of the GBWR team. Record application processing may take 01 to 90 days from the date of receipt of the application. After processing the application, a Record Claim ID and Record specific rules & regulations would be provided.
- GBWR team member or Record Management Judge need not to be mandatorily present at the time of attempting a record. However, the authenticity of the record should be properly taken care of by having either an adjudicator/s or/and witness/es at the record attempt location.
- At least two witnesses should be present at the time of attempting the record. The complete details about all the witnesses and witness statements should be enclosed with the claim documents. All the documents should be duly signed by all the witnesses.
- After attempting the World Record, it is mandatory to submit the 'Record Claim Form'. Approval of claim and
  issuing the certificate is done only after receiving the Record Claim Form along with necessary evidence and
  the complete process of attempt verification. All claim materials/documents/evidences submitted to GBWR
  will be a property of GBWR subsequent to the record claim. GBWR is under no obligation to return any kind of
  claim materials/documents/evidence back to the attempter/attempting organization.
- You can opt for adjudication of record by filling the inviting adjudicator column.
- Record Application form should be mailed at <u>contact@goldenbookofworldrecords.com</u> clearly mentioning the applicant/s name, address and contact details.
